***In order to be approved for a taxicab business license, an applicant must:***

- Obtain and complete application forms from the City Clerk's Office.
- Each principal officer of the applicant, if a corporation or all persons having an actual ownership interest in the applicant shall sign and verify the application.
- Provide a comprehensive list including the make, model, passenger capacity, year, vehicle identification number (VIN), Taxicab identification number and license plate number of each vehicle to be covered by Taxicab license.
- Obtain written statement from the Sealer of Weights and Measures, at own cost, indicating the taximeter installed in each taxicab for which the taxicab business license is sought complies with the requirements of City Ordinance. (Provide to the Police Chief or his or her designee at time of inspection).
- Submitted those documents to the City Clerk with a nonrefundable annual fee for the Taxicab business license, a valid State of Maine motor vehicle registration certificate for each vehicle, and certificate of insurance from a reputable insurance agency stating that the vehicles for which the Taxicab business license is sought are insurance and listing the City of Old Town as an additional insured.
- Once submitted the Chief of Police or his or her designee, will contact the business for inspection.
- Obtain from the Chief of Police, or his or her designee, a written statement that an inspection has been made of each Taxicab for which the Taxicab business license is sought and each Taxicab has been found to be safe and suitable for Taxicab service in accordance with City Ordinance.
- Once completed the Chief of Police, or his or her designee shall issue the valid taxi inspection sticker and taxi registration card for each eligible vehicle.

**Failure to meet any of foregoing requirements shall be grounds for denial of a taxicab business license.**
